To get a firm number of students participating in the trip, a **\$175.00 non-refundable payment by March 31, 2010 is required.** Anyone not returning this form, with the deposit, by this date will not be registered for the trip.

**PLEASE NOTE:** Students with outstanding fees or past due student account balances will not be allowed to register for the trip; this is a school-wide policy. **Any monies received will be posted to clear any outstanding fees/charges and past due balances before they are applied to the 2011 Spring Trip installments.** For Student Account status, please email Carol Smith at [csfam5@sbcglobal.net](mailto:csfam5@sbcglobal.net).

The deposit and subsequent payments may be taken from your Student Account if, 1.) the student is current on all fees and charges, 2.) the student has enough money in their account, and 3.) the student does not have any past due balances in their account.
